

## **HARRC Board Meeting Minutes 27 June 2016**

The June Board Meetings was held at Wagner & Spreha Law Offices and was called to order by President Kelly Spreha at approximately 7:08 PM. Board Officers present were President Kelly Spreha and Secretary Nicolette Bell. Also in attendance were Board members Mark Ondo, Fred Joslyn and HARRC members Paul Moretz and Frank Crupi.

### Prior Meeting Minutes:

With an update to the next meeting section, the minutes from the March/April 2016 Board Meetings were accepted on a motion by Spreha, seconded by Moretz and approved.

### Treasurer's Report:

Via email, Jason Fogelman reported the bank balance was \$21,790.93 as of June 27, 2016. Donations to the Harrisburg YMCA and the Area M Special Olympics still need to be made. The Treasurer's Report was accepted on a motion by Spreha, seconded by Joslyn, and approved.
